NO MORE DATA BOUNDARIES

The federal government needs a secure data exchange to deliver services efficiently and securely for their users and citizens. But making internal and external data available to different departments, partners, and citizens is difficult and error-prone with legacy data sharing methods such as FTP, cloud buckets, APIs, and ETL processes that are manual, spreadsheet-based, and time-consuming. Using data as a strategic asset means being able to easily and securely access real-time, comprehensive data, then enrich the data, leverage the insights, and share the information.

BETTER DATA GOVERNANCE AND CONTROL

Government organizations are trusted to be good stewards of data. Securing this data is critical to maintaining the trust of the citizens they serve. You manage your own data exchange from your Snowflake account, with the tools necessary to ensure data privacy, governance, and security. Snowflake meets NIST 800-145 requirements, is designated FedRAMP High Authorized, and has DOD Impact Level 5 (IL5) authorization. Snowflake also meets SOC1 Type 2, SOC2 Type 2, ISO 27001, FISMA Moderate, NIST 800-171, FIPS 140-2, ARS 3.1 PCI DSS, and HIPAA standards. You can control what data is made available, determine who can access that data, and view metrics to track data access and usage.

CENTRALLY MANAGED DATA EXCHANGE

Creating your own data exchange offers an advanced and simple way to exchange data, increase collaboration, and leverage data assets at scale. Agencies, departments, and separate organizations can collaborate within a controlled environment and across different cloud providers. Invite partners and citizens to access curated data assets securely, without having to copy or transfer data. This allows government agencies to protect data sensitivity and privacy and increase transparency.

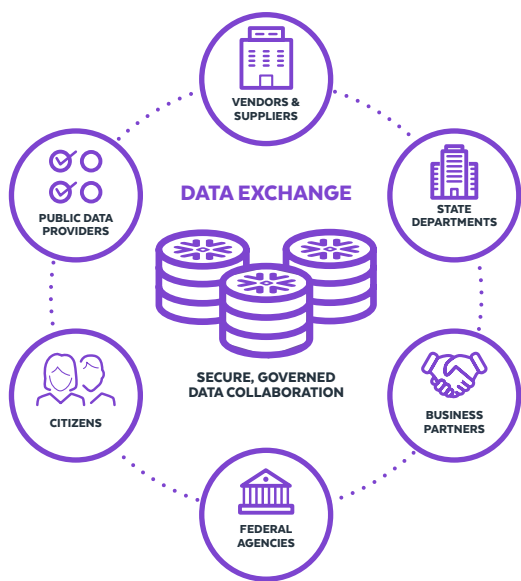
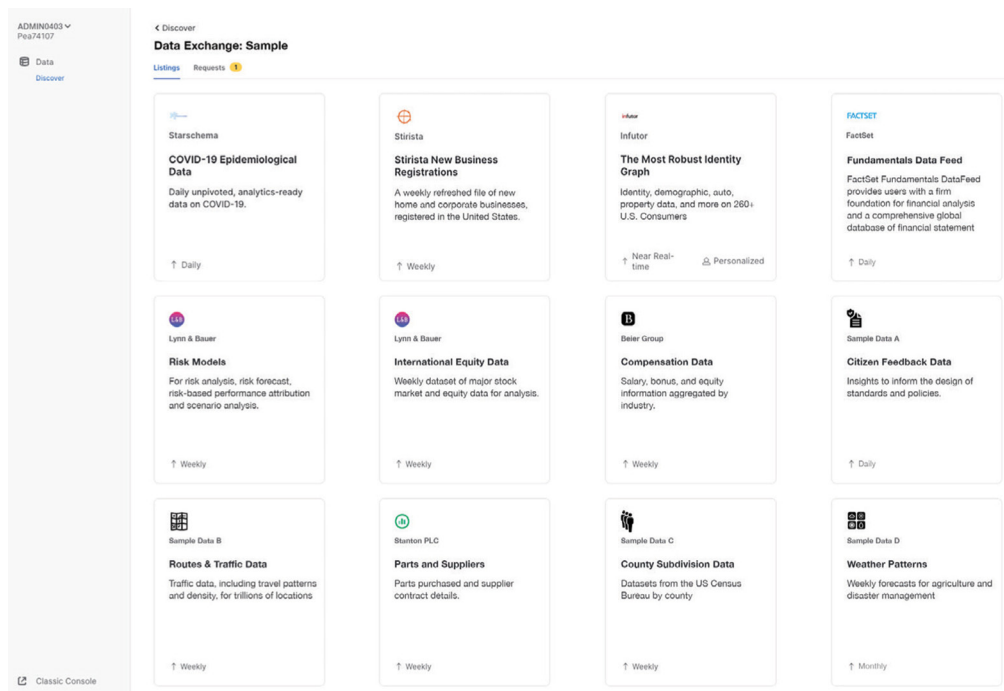
